LEON'S DEED was impeded leaving the gate, then gained lead down the backstretch and held well under a drive. ALPINE CREEK showed good early speed in the two path, was overtaken entering the turn, then came again to hold second. EARLY ARRIVAL stumbled leaving and was forced in at the start, settled off the pace, rallied up the rail and gained the show. FAVORITE BRAT chased the early pace, bid three wide on the turn and flattened out into the stretch. ROYALETTE broke in at the start and moved up to track the speed, failed to match strides and weakened in the stretch. VICTORIA'S GARDEN broke in at the start, raced toward the back of the pack, took the turn four wide and failed to produce a rally. SIBERIAN SNOW showed no early speed, took the turn five wide and couldn't summon the needed rally.
