KELLY'SPREMONITION allowed the pace to go early, stalked up the backstretch, bid second turn, showed the way past the furlong marker, challenged late, dug in gamely to narrowly prevail while along the rail at the wire. CAJUN CONQUEST settled off the pace, asked, angled out four wide late second turn, came in under repeated right handed urging to cut DOCTOR BRASCH off with a sixteenth to run, lodged a late bid outside the winner, denied. FOLLOWING A STEWARDS INQUIRY REGARDING THE STRETCH RUN, CAJUN CONQUEST WAS DISQUALIFIED AND PLACED THIRD. DOCTOR BRASCH lacked speed, continued back for a half, began to move far turn while along the inside, moved out a bit when within striking distance, cut off with a sixteenth to run and could not recover. LUMBERJACK CAT chased the early leader, challenged between rivals in the second turn, vied into the lane, began to weaken soon after. WAKKIANO off a bit slow, trailed, passed tiring foes. CATOFNINELIVES broke on top, soon got well clear, gave way when turning for home. ONE MORE KING lacked speed, had nothing for the drive. TOCCE'T'S CHARM was finished after a half.
