LEA JEANETTE away best of all, narrowly set the pace, disposed of the other speed exiting the turn, responded when challenged by the runner up soon after and held that foe safe the entire length of the stretch in a game effort. IRMASUE forwardly placed, advanced on the winner three wide late in the turn, bid, could not get by. BOCELLI'S SONG vied up front along the inside, could not keep up with the top two in the drive, lasted for the show. HOUSE OF STARS in the second flight while racing outside, four wide into the lane, lacked a winning response in the drive. FANNING THE FLAME in the second group while outside, came six wide out of the turn, went evenly in the drive. NO IDEA off a step slow, raced well back early, made a belated run through traffic and was going well at the end. LAKEWAY DANCER made little impact. LADY OF THE HARP saved ground to no avail, tired. SENORITA BRITNEY broke in to bother ASPEN TRAIL, moved up to race in the middle of the pack, had little for the drive. WHY SNOOP tired off the inside. I'M ON TIME was never a factor.

ASPEN TRIAL steadied at the start when cut off, trailed throughout in showing little.
