### Footnotes

ACTUAL FACT broke out, trailed for five furlongs, outside advance, bothered, carried out by a drifting foe upper stretch, finished up willingly to be clear. CLUB bothered at the start, settled inside, moved out, ranged up to challenge three wide in the second turn, narrowly showed the way past the furlong marker, could not contain the winner, clear for the place. NO ALIAS bumped at the start, chased the leader, challenged from between foes in the second turn, vied past the furlong marker, weakened late, comfortably held the show. IRISH FAITH broke alertly despite stumbling at the start, soon got clear to set the pace, began to weaken with replaced on the lead midway on the second turn, drifted out in upper stretch to bother the winner, continued to tire. MIDNIGHT CURFEW lacked a late response. SILKY'S DANCE raced outside through the first turn, improved a bit the middle half mile, had nothing left for the drive. LONOKE COUNTY finished early, stopped, distanced after losing contact with the field in the late going.
