KELLI'S LAW raced in the second flight while between rivals, set down for the drive when straightened for home, finished with good late energy to be in time. SWEET DEBBIE set all the pace, got clear in the turn, caught in the late going. PEACEFUL CITY within striking distance widest of all, lacked a winning kick. SEXY ROSE rated off the pace toward the inside down the backstretch, lacked the needed response when the real running started at the head of the lane. HUMBLE MADELINE pressed the runner up early, staged a steady retreat before a half. TELL ME SWEETLY bobbled slightly at the start, was never involved. CHRISTAVILLA stumbled badly start, unseated rider.
