QUILL OUT lacked early foot while between foes, came three wide into the stretch, moved out, finished fast to be in time. ARCTIC WISPER also outrun in the early going, saved some ground into the stretch, switched to the outside for the drive, up for the place. DYNACAST prompted the pace while off the inside, set down for the drive, nipped for the place late. MACHO TIME set the pace most of the way along the inside, weakened. LAC VALENTINE well back for six furlongs, improved position. WESTERN PINE turned in an even effort while off the inside. TALE OF THE TAPE within striking distance, lacked a response in the drive. DE CHESTNUT prompted the pace for over seven furlongs and gave way. NOCHANGENWEATHER had little left for the drive. L'AS DE PIQUE stopped in the far turn, distanced.
