TIME'S CONCERN behind the pace, advanced out of the turn, challenged between foes, slight drift, brushed, edged clear late under firm handling. MANIFOLD outrun early, advanced four wide into contention out of the turn, bid on the outside, brushed, outkicked in the late going. C R LEGEND late away, void of early foot, late rally well out in the strip to be up late for the show. OSTENACO raced back in the early going, staged a modest rally to improve position. COCHISE STRONGHOLD with the pace outside after an alert break, continued to contest the pace through the turn, gave way in the late going. PANCHO'S SILVER dueled up front closest to the inside, faltered. ZARBY'S HOME five wide through the turn, failed to rally. MAILMAN MAX remained back in failing to menace. NEWFIE SPIRIT tired from early efforts. SHORTY SMALL was never close. AT THE DOUBLE staged a steady retreat.
