IRONIC CHARMER reserved early, four wide when beginning to rally into the stretch, finished willingly to be in time. HOT ROCKET narrowly set the pace, garnered a slightly larger advantage in the second turn, responded when challenge in the stretch and proved game to the end. COUNTRY CAUCUS never far back, challenged the runner up nearing the furlong grounds, was outfinished between foes. MACARONI GIRL evenly paced throughout, lacked a late kick. JUDICIARY with the early pace, fell back and had little left for the drive. RHONDA LEGS' STORM four wide out of the final turn, lacked a late bid well out in the course. OSO DEVILISH failed to menace. SUNDRRESS pinched start, trailed most of the way to be outrun. TIDEFALLS off slowly, was never involved. NO NO BAD KITTY dueled up front while closest to the inside, stopped in the second turn.
