PROVOBAY away well, set a slow set of early splits, repulsed a bid late in the second turn, regained a daylight advantage into the lane, held sway late. VOLOBEE (FR) allowed to settle well off the early pace, roused for the drive while outside, no match winner, game for the place. CAROLYN FRANCES in the second flight, saved ground into the lane, outfinished for the place spot. ABBEYS RUNNER three wide through the second turn and into the stretch, not enough kick to the wire. BITTERSWEET BONNIE forwardly placed, tried the winner turning for home, failed to sustain that effort in the drive. TUNNEL TIME saved ground to no avail. TELL NO TALES raced outside, made little impact in the drive while continuing wide. CASH COUNTER no threat. TINCAN TOO finished early, dull effort. SHONS SECRET four wide in the first turn, outrun.
