### Footnotes

FLY TERRI FLY broke alertly, narrowly set the pace off the inside, well rated while continuing to show the way through the turn and into the stretch, edged away in the late going under steady handling. UNREAL APPEAL pressured the winner from along the inside, continued closest to the that rival through the stretch, could not match strides late, lasted for the place. JETTIN JANA off a step slow, fell further back, moved out to be widest for the drive, finished willingly to be gaining on the top two out in the center of the strip. GHOSTLY APPEAL bobbed at the start, in the second flight, between foes into the lane, lacked winning kick late. MY SUGAR BRITCHES in the second group while racing in the two path, set down for the drive, also lacked a significant late response. JUKIN N JIVIN lacked speed, came five wide out of the turn, called on for some run, little in the tank late while well out in the strip. LINDA'S ROSE bobbed at the start, raced forwardly and four wide through the turn, weakened.
