HER LAKE TERLINGUA lacked speed, waited behind a wall of horses midway on the final turn, swung out five wide turning for home, closed with good late energy to be in time. SHERRMYGIRL off the pace, advanced four wide into contention second turn, took over nearing the furlong marker, proved no match for the winner late. GOOD KITTY forwardly placed, challenged along the rail turning for home, not good enough. JOVE JOVE DIVE settled off the pace while toward the inside, four wide and in some traffic turning for home, went evenly the final furlong. ASPEN TRIAL saved ground while behind the pace, continued inside, lacked needed response drive. LOUISIANA SHINE reluctant to load, settled off the pace and the outside, went evenly in the drive. BEER N CRICKETS broke on top, set the pace while rating early, allowed GOOD KITTY the inside turning for home, between rivals upper stretch when vying for the lead, gave way final furlong. LUCKY SPANX settled off the pace, lacked a late bid. SWEET EMILY last away, trailed most of the way, picked off couple of tiring foes, no threat. WHY SNOOP remained always back. QUEENS WALK prompted the pace off the inside for three quarters and stopped.
