Footnotes

SERA'S TUNNEL allowed the pace to go early, steadied slightly in some traffic when moving closer late in the final turn, moved out, finished willingly to be clear late. COUNTRY CAUCUS within striking distance, ranged up four wide to challenge turning for home, narrowly showed the way past the furlong marker, could not match the winner late, held sway for the place. DREAM MOUNTAIN forwardly placed toward the inside, boxed in turning for home, fell back, switched out, finished up willingly to be closing the gap on the runner up. RIINA four wide when forwardly placed into the first turn, chased the leader, bid, vied past the furlong marker, weakened. R S VALENTINE lacked early foot, three path, angled out for the drive, improved a bit while never dangerous. STACEY LEE last to leave, raced back, improved into the lane, flattened out a bit and managed little in the way of a late gain. WANDASLITTLEANGEL lacked a late bid. JUDICIARY in tight, sprinted clear soon after the start, set the pace then weakened when headed turning into the stretch. DANCINGWITHNOMUSIC off the pace, floated out seven wide when BINGO IS MY NAME came out, remained back through the stretch. WAITING FOR YOU broke in, showed little while racing off the inside. BINGO IS MY NAME settled off the pace, got out a bit to be six wide while carrying DANCINGWITHNOMUSIC out turning for home, faded.
