SHERRYMYGIRL outrun in the early going, in some traffic while four wide late in the final turn, split foes nearing the furlong marker, finished willingly to prove best. ASPEN TRIAL lacked speed, raced in some traffic then waited late in the final turn, moved out for the drive, moved out wider inside the furlong grounds to slightly bother TEARS IN MY EYES, continued with good energy to the wire to earn the place. A CLAIM OF FOUL BY THE RIDER OF REARS IN MY EYES AGAINST ASPEN TRIAL FOR ALLEGED INTERFERENCE IN DEEP STRETCH WAS NOT ALLOWED. TOUGH MADAME also well back off the early pace, five wide gain into the stretch, flattened out the final furlong. LEESTOWN LILLIE broke out, forwardly placed, took over along the inside second turn, showed the way past the furlong marker but could not last. TEARS IN MY EYES broke in the air, raced far back for three quarters, came five wide into the lane when beginning to advance, bothered slightly when the runner up came out with a sixteenth remaining, finished up evenly. FOREVER BLUE settled off the pace, waited in some traffic turning for home, came up empty when clear. STARFISH four wide through the first turn, traffic late in the final bend, tired in the drive. ARCE DOCE closest to the leader, vied briefly into the stretch, stopped in the drive. SWEET INTUITIONS showed way early, clear before a half, stopped far turn, distanced.
