**Footnotes**

POWER SURGE ran off prior to the start, away in good order, stalked the early leader, took over in the turn, drew out stretch. SONIC FLIGHT settled off the early pace, roused for the drive, finished willingly to remain clear for the place. VALIDJO broke sharp, set the pace into the turn after clearing early, raced briefly on equal terms with the winner when that one came alongside in the turn, weakened in the drive, managed to hold the show. JULIE'S RED BANDIT within striking distance behind the two leaders in the turn, lacked a late kick, outfinished for the show. APPELLATE COURT went evenly paced throughout while toward the inside. GRAN PUNCH lacked a late bid. CHAWNADO broke to the inside, steadied, fell back, no threat. STAG'S GLORY cut off at the start, lacked bid. ROAMING AROUND off slow, trailed.
