SKIPPING TOWN broke on top, rated early, set all the pace along the inside, maintained a daylight advantage to the wire under steady handling. GECOWOWA within striking distance, roused for the drive, exchanged bumps with SOUTHPINE down the lane, outkicked that one for the place. SOUTHPINE closest to the winner, exchanged bumps with the runner up inside the furlong grounds, outfinished by that one for the place spot. RIINA lacked speed, angled out a bit for the drive, finished up evenly. TOKEN DIVA off the pace, angled out when advancing exiting the second turn, lugged in a furlong out, did not recover. MY STORMY ANGEL had little left for the drive. HOLY JOSY tired from her early efforts. BINGO IS MY NAME last away, trailed throughout.
