TORTUGA STRAITS slightly reluctant to load, raced with the pace four wide into the turn, continued on the outside and kicked well clear in the drive. SONIC FLIGHT forwardly placed early, shuffled back a bit toward the inside early in the turn, continued to race toward the rail and was up late for the place. VICTORIOUS ACT broke in the middle of the pack, moved a bit closer on the outside into contention turn, closest to the winner past the furlong marker, caught for the place. BIG EXPECTATIONS prompted the early pace, fell back a bit in traffic turn, finished up evenly. APPELLATE COURT away in good order, lacked a closing kick. MARK SAFELY narrowly showed the way for a half, gave way when headed by the winner turning for home. STAG'S GLORY broke to the inside, not a threat. DADDY'S MISTRESS failed to menace. BAYOU DE STORM four wide late in the turn, tired. GRITTY WALKING forced in at the start, was not a factor. BAD STORM BRUIN ran off prior to the start, off slow, remained well back throughout. JOE'S MAJESTY fractious while loading, brushed the gate start, trailed throughout.
