GOODZEE TOUGHZEE unhurried early, advanced on the outside while still in hand far turn, challenged four wide into the stretch, drew steadily clear while kept to pressure. DERBY DAY vied up front along the inside, roused in the second turn, lost some position into the lane despite that urging, battled back to earn the place while not a threat to the winner. BEER BELLY forwardly placed off the inside while four wide in the first turn, ranged up to challenge four wide in the far turn, vied into the stretch, also proved no match for the winner, outkicked for the place. DEADEYEDOGE broke in, raced with the first flight, between rivals in the second turn, weakened in the drive. LEES DELTA lacked speed, saved ground, set down in the second turn while continuing inside, improved position slightly. WON FOR KING settled off the pace, steered out to be four wide turning for home, made little impact in the drive. DOUBLE DOWN DELTA void of speed in trailing early, passed tiring rivals after the issue had been decided. TEXAS PEPPER bobbled slightly at the start, raced back, never a threat. THUNDER'S STAR used early while five wide to make the first flight into the first turn, vied three wide, gave way in the final turn. UNBRIDLED FLATTERY off the pace while outside, moved briefly closer second turn, gave way while five wide into the lane.
