SLIGO JOE settled off the pace, shaken up late in the second turn with a brisk right handed stick, made steady progress down the lane to be in time. MAE B TODAY sprinted well clear soon after the start, maintained a large advance up the backstretch, turned back a bid into the stretch, shook clear again, slight drift late when clear, caught. A CLAIM OF FOUL BY THE TRAINER OF WAKE UP SAL AGAINST MAE B TODAY FOR ALLEGED INTERFERENCE IN DEEP STRETCH WAS QUICKLY DISALLOWED. WAKE UP SAL allowed the pace to go, saved ground, closer stretch, lacked a closing kick. HIGH STAKES SILVER closest to the leader, closed the gap far turn, flattened out in the drive. HOWELL PARK fell back to trail, improved position slightly in the drive, no real threat. BOREGO'S BARBARIAN void of speed, came four wide out of the final turn, passed tiring rivals. EL OTRO back off the pace, four wide out of the final turn, failed to rally. LINDAU four wide in the first turn, continued outside, lodged a brief bid on the second turn, hung. MOON ON FIRE tired.
