EASTER ANGEL with the pace from the start, vied into the stretch closest to the inside, edged away late under steady handling. LU LU PRODUCTION prompted the early pace, moved up to contest the issue while three wide out of the turn, remained on equal terms with the winner past the furlong marker, could not match strides with that foe late, clear for the place. DEBONAIRE DOLL set the early pace, vied between foes into the lane, weakened, lasted for the show. JOYFUL PRAISE off the pace, moved out and was four out to five wide into the stretch, went evenly to the wire. BRICK BRACK toward the front early and in some traffic, also lacked a serious late bid. AL TEE back off the pace, five wide out of the turn, another who failed to muster a rally. CHLOE'S A CHARMER forwardly placed early, weakened. LOUISIANA MAGIC void of early foot, improved position slightly, never dangerous. HUANA CREEK POINT off a bit slow, no menace with a four wide trip. ERL'S SPIRIT fell back to trail after the start, was always outrun. PERSONAL A. T. M. fell back in the turn, steadied between foes a quarter out, moved out five wide into the lane, remained back. LUCYANNA ROSE backed up in the drive.
