SEA THE SOLDIER prompted the pace in the three path and under restraint, took over turning for home, drew out as he pleased to win ridden out. ROCKITTOWN outrun in the early going, moved up closer four wide late in the second turn, proved no match for the winner, clear for the place. TIMELY DELTA set or forced the pace along the inside, weakened in the drive, lasted for the show. COUR D'APPEL went evenly throughout in lacking a late response. REGENT RULES a pace factor off the inside for six furlongs, gave way in the drive. DAKOTA PRINCE trailed.
