### Footnotes

ZARB'S GUNNER moved up along the inside, vied through the turn while continuing on the rail, drew well clear in the drive. SETEMUP JOE settled off the pace, followed the winner into the lane along the rail, moved out a bid, could not do much with that foe in the drive, clear for the place. PONOPAAN back early off the pace, advanced off the inside, finished best of the rest. MOTOR HOME went evenly in lacking a late bid. MAN O'CHOICE failed to rally from the three path. MT. LOVERBOY away alertly, showed the way out of the chute, continued to set the pace until headed by the winner late in the turn, gave way. STORMY SURGE wide out of the turn when falling back. MEAN CONTRACTOR was never involved.
