FOR TWO YEAR OLD FILLIES. (Includes \$50,000 from Slot Revenue). No nomination fee. \$250 to pass the entry box and an additional \$250 to start. \$50,000 Guaranteed to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth with any unpaid monies reverting to the purse account. Weight: 121 lbs. Non-winners of a sweepstakes allowed 2 lbs.; a race other than maiden or claiming, 4 lbs.; a race other than claiming, 6 lbs. The Donnie Wilhite will be limited to eleven (11) starters.

Preference to horses with the highest earnings. Different owners will have equal draw according to earnings. The second part of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. The owner of the winner to receive a trophy. Nominations closed Saturday, July 21, 2012 with 23 nominees. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at 1 Mile and 70 Yards).

**Footnotes**

PROMISE ME MORE last away, raced unhurried for six furlongs, came five wide into the straight when moving smartly, continued full of run past the furlong marker, collared the leader soon after and won going away. MY DAUGHTER'S SONG took command soon after the start, set the pace while in hand, shook clear with a furlong to run, proved no match for the winner late. FLEET DAWN settled off the pace, saved some ground second turn, off the rail for the drive, lacked a winning kick, finished up best of the rest. LONNIE BELL within striking distance off the inside, came three wide into the lane, roused, came up empty the final furlong. MISTY SWAMP off the pace into the first turn, steadied in some tight quarters soon after, went evenly through the stretch. RULERSHINYFUTURE pushed out to be five wide midway on the first turn, continued outside, four wide through the second bend, lacked a rally. PLATINUM SONG slight bother when MISTY SWAMP steadied in the first turn, raced back, saved ground into the straight, also lacked a closing response. HUNTERS ROSE forced the issue for five furlongs, gave way in the drive.
