KEY DONATION away well, allowed the leaders to go early, stalked in the run up the backstretch, between rivals in the second flight into the turn, moved to engage the two leaders after being asked for some turn turning for home, edged steadily clear the final sixteenth under firm left handed pressure while drifted out a bit late. TENSAS COLD FRONT moved up inside to duel past the wire the first time, alternated up front in the run up the backstretch and into the lane, gave ground grudgingly to the winner the final sixteenth, held well for the place. MR BLUEGRASS MUSIC forwardly placed while outside, continued to prompt the issue the middle half, 4w into the lane, outkicked for the place. MASTER RICK alternated up front outside the runner up, held a narrow advantage past the furlong marker then faltered in the late going from between rivals. KING CORAL settled off the pace while saving ground, roused when straightened for home, little in the way of a response. SOMMER'S CHOICE lacked speed, roused in the two path turning for home, also failed to respond. NOBLE ALEX three wide trip, remained back. STEADY ROAR last away, trailed, fell further back, distanced after losing contact with the field.
