**Footnotes**

DOUBLE GRAN prompted the pace from the outside, challenged into the stretch, brushed, long drive, proved best in a determined effort. NATIVE HOLLY got clear early after an alert break, continued to show the way up the backstretch, responded when challenged by the winner entering the straight, came out, brushed with that foe, outfinished. AIDEN'S AFFAIR broke on top, raced forwardly and off the inside, lacked a winning bid in the drive. SAUCY MISS broke to the inside, steadied, raced well back, five wide out of the final turn, finished up willingly to significantly improve position, too late. BEFORE HER TIME lacked speed, improved four wide through the second turn into a striking position, flattened out in the drive. EULOGIZE FASHION came out into the first turn, settled in midpack, lacked a late kick. LAURA'S MIRAGE broke to the outside, raced in the second flight along the inside, came up empty for the drive. STACEY LEE lacked early foot, picked off some tiring foes while not a threat. ROBBIELEE pinched back at the start, not a factor. WALKEN IN THA HEAT was finished after a half. FOOLISH MANDATE carried wide into the first turn, five wide through the second when beginning to fade, finished well back.
