Footnotes

GRETTL TOOT got clear early, set a moderate set of fractions, dueled through the second turn and into the lane, headed by two rivals a furlong out, came back in game fashion while continuing inside. LIVEALITTLEBIT within striking distance, continued to stalk far turn, called on for some run into the lane, challenged three wide inside the furlong grounds, outfinished while between foes at the wire. HIGHFLYINGPRINCES lacked speed while four wide into the first turn, moved to the far outside for the drive, set down, finished willingly to be steadily closing the gap. SERA'S TUNNEL closest to the leader, moved up and dueled with that one second turn and through the stretch, had a head in front with less than a furlong remaining, hung in the late going. NICOLE DENMAN one paced while one lane off the rail, lacked a winning response. LIGHTUP THE SHADOW made little impact while also racing off the inside. LITTLE PEANUT raced three wide and had nothing for the drive. HERE'S TO TOMORROW off slowly, remained back throughout. TRI DANCER tired from her early efforts.
