CONFIDING WINNER broke alertly, set all the pace, drew out drive under token encouragement. LAWYER LAUREN last away, saved ground through most of the turn, angled out for the drive, finished willingly to earn the place while never a threat to the winner. SPIRITED SIS raced outside, roused for the drive, closest to the winner past the furlong marker, outfinished for the place spot. PRINCESS BIRDEYE forwardly placed along the inside, had little left late. MILTON'S KRUGERAND within striking distance early, lost some position in traffic late in the turn, came up empty when clear. TWILIGHT CODE never menaced. MAGIC WEAPON chased the winner for a half and gave way.
