SAINTLY DEMEANOR forwardly placed while four wide through the first turn, continued to force the issue while four wide in the second turn, roused for the drive, put a head in front upper stretch and drew clear under continued pressure. GHOSTLY APPEAL showed the way early, raced closest to, but not on the rail, continued to hold a narrow advantage into the stretch, failed to keep up with the winner, comfortably held the place. SURPRIZED WINNER lacked early foot, staged a mild rally to be along for the show outside. NETTIE HUGHES prompted the pace well off the inside, vied three wide and inside the winner into the lane, weakened. GREEN BRIAR KITTY off a step slow, failed to threaten. TIKA SOUP pressured the runner up for five furlongs and gave way. SKIPTease finished early, fell further and further back, distanced.
