### Footnotes

CAN'T COMPLAIN dueled up front closest to the inside, shook clear of the other speed when straightened for home, kept to task. RUN BRICK RUN alternated up front outside the winner, fell back off that one, held the place. NO RULES NOW last away, steadied slightly midway on the turn when still well off the pace, saved ground into the lane, split foes, finished willingly to be getting to the winner. DRYDEN raced off the pace and the inside, three wide into the lane, bit closer midstretch but lacked a significant late response. DERBY FLEET well back, angled out sharply to be five wide out of the turn, improved position while never dangerous. KRISTENS REBEL chased the top two through the turn, had little left for the drive. AUTHENTIC FLYER tired in the drive. BUCKABOO in some traffic into the turn, steadied, fell back. PASS D SPORTSPAGE finished early, raced wide, was eased under the wire, walked off.
