FOR ACCREDITED LOUISIANA BRED FILLIES AND MARES, THREE YEAR OLDS AND UPWARD. (Includes \$60,000 from Slot Revenue). WEIGHTS: Three Year Olds 120 lbs.; Older 124 lbs. Non-winners of \$30,000 in 2011 allowed 3 lbs. Non-winners of two other than maiden, claiming or starter 2011 allowed 5 lbs; Non winners of one other than maiden claiming or starter in 2011 allowed 7 lbs. No nomination fee. \$300 to pass the entry box and an additional \$300 to start with \$60,000 Guaranteed to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth with any unpaid monies reverting to the purse account. Starters to be named through the entry box by the usual time of closing. Preference to horses with highest money earned in 2010-2011.

Different owners will have equal draw according to earnings. The second part of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. The owner of the winner to receive a trophy. Nominations closed Saturday, August 6, 2011 with 43 nominees. (S)

DAPHNE ANGELA steadied start, raced back early as a result, began an early advance after a quarter, reached the front four wide turning for home, drew well clear in a sharp effort. GOOD HUMAN BEAN with the early pace while four wide, continued to vie on the outside turn, came into the stretch between foes and inside the winner, proved no match for that foe, held the place. LITTLE POLKA DOT with the pace for a half along the inside, fell back into the lane, moved out a bit, coming back for the place. THRUTHEGARDENGATE broke in, recovered to race forwardly, moved to join the fray into the turn, weakened four wide turning for home. U BELONG TO ME fell back off the pace in the two path for a half, moved out to be three wide into the lane, improved slightly. CHERRY FOREVER lacked speed, angled out to be four wide when asked for run turning for home, lacked a serious bid. RUNNING SHOES narrowly set the pace for a half between foes, faltered in the drive. REYINA failed to menace. SAINT BELINDA last to leave, continued back, no rally. SWEET RUSTON void of speed while outside, carried out five wide exiting the turn, tired.
