### Footnotes

ILLUSION OF SPEED lacked speed, swung out to be five wide turning for home, collared the leader inside the furlong grounds, clear, held late. SHEZA FAST MOMMA lacked speed, came three wide into the stretch when beginning to rally, moved out a bit for room, finished willingly out in the strip to be getting to the winner. SAINT BELINDA vied early along the inside, fell back in the turn, moved out for the drive, trying to come back. MISS LEWIS pressed early outside, took over turning for home, got clear, faltered. PURRFECT GEM narrowly set the pace off the inside early, dropped inside turn, gave way in the drive. POLITE AND COZY in the second flight early while between foes, faded. CREME DE CACOA had nothing for the drive toward the inside. ST. PATSY last away, trailed early, lacked a significant response while four wide. Z FEME FEME FEME broke out, four wide into the turn when with the second group, gave way.
