GREY IDE LADY took over soon after the start, set the pace while rating toward the inside, increased advantage through the stretch, kept to task. BEFORE HER TIME brushed start, off the pace, roused and advanced while five wide late in the turn, edged clear for the place while no match for the winner the final furlong. MAUI CRUSIER off the early pace, improved through traffic in the turn, along for the show late while racing toward the inside.. BERRY BALL void of speed, passed tiring foes to improved position off the inside. T C'S STAR raced closest to the winner for a half then gave way in the drive. MOONSHINE COUNTY within striking distance early, tired. REBEL'S BAG brushed at the start, forward early, was giving way late in the turn when five wide.
