SOLDIER'S COURAGE broke to the inside, narrowly showed the way early inside, garnered a larger advantage through the turn, headed approaching the furlong marker, bumped with the runner up, battled back in game fashion while remaining on the inside. DISTRICT APPEAL also broke in, pressured the winner from the outside early, fell back off that rival a bit in the turn, challenged upper stretch, put a head in front midstretch, bumped, outfinished. COUNTDOWN TWICE broke to the inside as well, one paced in the two path, no match for the top in the drive. CORNER STORE broke a step slow, raced back, saved ground through the turn, improved position a bit in the drive while continuing along the rail. RUNNYMEDE NATIVE within striking distance early, moved a bit closer on the outside late in the turn, hung in the drive. CAPTAIN HORATIO was finished early.
