Footnotes

RIMFIRE'S THUNDER allowed the pace to go early, came four wide into the stretch, bid, took over past the furlong marker, clear, held the runner up safe in the late going. TROUBLED SON last away, trailed well back, came to the outside for the drive, late run down the middle of the course to be getting to the winner. SHEIK OF WAGONER lacked speed, staged a belated rally while also well out in the course. SAVANNAH CREST moved closer three wide turning for home, lacked a winning kick. TIGER WALK saved ground into the stretch, blocked upper stretch, finished evenly. ZARB'S ECHO lacked a late bid. JOLIE'S GIFT had little left for the drive. CROWD WATCHER cleared early, gained a larger advantage in the second turn, gave way when confronted for the drive. L'HOMME forwardly placed for six furlongs, also backed up in the drive. SILVER ON SILVER raced closest to the leader for five furlongs, pulled up when giving way in the second turn.
