WHERE'S CAIN with the first group while three wide, continued to vie into and through upper stretch, drove well clear late. EUGENE'S MOMENT with the pace along the inside, dueled with the winner past the furlong marker then could not keep up, clearly second best. KAT'S COURT lacked early foot, came four wide when heading up the second flight out of the turn, could do little with the top two the final furlong, along for the show. MR. SHORTY vied up front while between foes for a half and began to weaken. KISSIN CHILD lacked a late bid. PAID UP saved ground to no avail.
