Footnotes

LADY MCBEE behind the pace along the inside, waited briefly for room late in the turn, moved out, challenged between foes inside the furlong marker and proved best under firm handling. ANGEL IN CHARGE forwardly placed outside, moved up to put a head in front a furlong out, could not contain the winner. HUMBLE MONIQUE lacked speed, carried out five wide late in the turn when beginning to rally causing SHECANDO to clip heels, finished well while widest in the lane. SPROCKET ROCKET with the pace along the inside, weakened in the drive. PEPPERMINT GOLD trailed early in lacking speed, found best stride too late through traffic. BONA FIDE WISHES bit tight at the start, made little impact. ROB CON forwardly placed and outside for a half, drifted while tiring down the lane. LONE STAR TIME well off the pace, came out a bit late in the turn carrying HUMBLE MONIQUE out, lacked a late bid. ANNABELLE S. lacked a response. MISS ANGEL EYES set or forced the pace for a half off the inside and gave way. FROSTY FLASH was never involved. SHECANDO last away, trailed, was five wide when clipped heels late in the turn, fell, lost rider.
