LITTLE WHISKEY unhurried, six wide turning for home, rallied out in the middle of the course, up in time. HEAD TURNER vied up front early inside, fell back the middle half, moved out for the drive, rebid a furlong out, caught late. UNDESIDED four wide into the first turn, continued outside, four wide again late in the second turn, lacked a winning response. FRONT LINE LAWYER lacked speed, improved off the inside, mild late interest. HARD WORKING DAN prompted the early pace, took over before a half, continued to show the way into and through upper stretch, faltered the final furlong. STEWY fractious in the gate, trailed in showing little late interest, improved late by passing tiring rivals. DIVIDED five wide into the first turn, tired. PROVOKE ME lacked speed, never a serious threat. JENNIE'S LITTLEMAN tired while racing off the inside. DAVY'S RUNNER flashed brief speed and stopped.
