Footnotes

TOPVENTURE'S DREAM dueled up front closest to the inside, put the other speed away late second turn, was challenged soon after, responded when another rival moved up the inside to challenge with less than a furlong to run, long drive, proved best in a determined effort. WAKKIANO in the second flight toward the inside for six furlongs, moved out, came four wide into the stretch, lost some ground, late bid,, not enough. ROUGHHOUSE allowed to settle, moved closer along the inside far turn, inched closer stretch, rail bid a sixteenth out, hung late. ASHLEY'S VENTURE four wide when forwardly placed in the first turn, remained within striking distance, challenged three wide turning for home, lost whip a furlong out, outkicked late. ZARB'S WHIRL lacked early foot, moved closer in some traffic in the second turn, roused, moved out a bit for the drive, came up empty. RED VENTURE well back for five furlongs, five wide when improving a bit in the second turn, failed to sustain that advance in the drive. MARION PONDEROSA void of speed, came seven wide into the stretch, picked off some tiring foes while not a serious threat. RED HOT WALK dueled up front outside the winner, gave way from between foes turning for home. TEIXEIRA tired after a half. MIDNIGHT CURFEW broke slowly and was always outrun. LOGAN'S PRIZE settled off the pace, was tiring late in the second turn when bothered, continued to fade.
