MISS FLIT N FLOT void of early foot, raced in traffic then angled out to be four wide into the straight, finished willingly to be clear. VICTORIOUS HOUR forwardly placed, lodged a bid while off the inside late in the second turn, could not match the winner late, clear for the place. MADELYNN ROAD allowed to settle, came three wide turning for home, roused, lacked a significant closing response. GOODBYE BEAUTIFUL prompted the pace, also was going evenly under the wire. ZARPEN set the pace, got briefly clear backstretch, faltered in the drive. G. I. JANA lacked a bid. EM AND MAG'S LADY saved ground to no avail. GENTILLY SUNRISE off slow, four wide out of the final turn, did not rally. ASHLEY COUNTY was finished after a half.
