CAT'S PRODUCTION broke alertly, allowed the leader to go early, remained closest to that rival in the run up the backstretch, moved to challenge into the far turn, showed the way into the stretch, shook clear, enough left to hold the runner up safe late while fully extended. LAWYER TIFFANY broke out, pulled early while off the pace and the inside, continued to be patiently handled through the second turn while three wide and between horses, roused for the drive, closest to the winner a furlong out, gaining on that foe late. MUFFIN lacked speed, came five wide into the stretch, closet to the top two midstretch, could do little with those two late, held the show. CLEVER THIRTEEN evenly paced while within striking distance inside, lacked a significant closing response, outfinished for the show. RILEYS MONARCH void of speed for six furlongs, came four wide into the lane, passed tiring rivals. MADAMEDIRTYNELLIE moved up inside to be clear before a quarter, continued to show the way, gave way when headed by the winner turning for home. WANNA CUDDLE lacked speed, encountered some traffic late in the second turn when moving a bit closer toward the inside, lacked a response when clear in the drive. ANYTHING BUT QUIET off the early pace, lodged a mild middle move, four wide second turn, gave way in the drive.
