### Footnotes

TEARS IN MY EYES void of any early foot, continued to trail up backstretch, came five wide out of the final turn when commencing her rally, finished fast to be just up. BYARS LADY broke in, raced back early while saving ground, advanced along the inside second turn, lodged a quick bid after angling out three wide into the lane, took over, led late, nipped at wire. DE FRISKY SEQUOIA forwardly placed, advanced and challenged between rivals and inside the runner up turning for home, could not match that rival the final furlong nor prove any match for the winner, well clear of the rest. TIZ MY PRAYER broke alertly, soon cleared to the inside, large lead in the run up the backstretch, faltered when confronted in the drive. RITA'S WAY made little impact from well back. KAKI CAIN fell back to trail into the far turn, moved out widest for the drive, passed tiring rivals. CERTAINS TIERRA tired while racing four wide into the lane. SHILOH MISS closest to the leader for six furlongs, gave way. STAR DELTA was finished after a half.
