**Footnotes**

LEE'S ANGEL close from the start outside, vied four wide through the turn, showed the way upper stretch, garnered a larger advantage a furlong out, enough left to hold the runner up safe late. SUGARTOWN LADY void of early foot, advanced six wide out of the turn, finished willingly well out in the strip to be getting to the winner late. CORRIENDO RAPIDO far back in the early going, in some traffic into the lane, dropped inside for the drive, finished up willingly while continuing inside. DAY GIRL forwardly placed, vied along the inside through the turn, had little left for the drive. FOXY APPEAL settled off the pace, in traffic upper stretch, moved toward the inside, improved position slightly without proving dangerous. MISS CAT GAC with the pace for a half, put a head in front from between foes in the turn, faltered in the drive. MANNEQUIN trailed in the early going off the inside, improved by passing some tiring foes in the drive, no real threat. VIRGINIA VIKING tired while racing five wide. OUTSIDER broke alertly, set the pace off the inside, vied between rivals through the turn then gave way in the drive. U SCENE MORONI four wide when off the pace through the turn, in some traffic upper stretch, moved to the outside, finished up evenly. HOUSE OF STARS tired after saving ground through the turn. LITTLEBIT OF FAITH was never close.
