FOR THREE YEAR OLDS AND UPWARD. (Includes \$50,000 from Slot Revenue) WEIGHTS: Three Year Olds 121 lbs.; Older 124 lbs. Non-winners of a sweepstakes at a mile or over on the turf in 2010 allowed 2 lbs.; non-winners of two races other than maiden or claiming at a mile or over on the turf in 2010 allowed 4 lbs.; non-winners of a race other than maiden, claiming, or starter on the turf in 2010 allowed 6 lbs. No nomination fee. \$375 to pass the entry box and an additional \$375 to start with \$50,000 Guaranteed to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth with any unpaid monies reverting to the purse account. Starters to be named through the entry box by the usual time of closing. Preference to horses with the highest earnings in 2009-2010. Different owners will have equal draw according to preference. The second part of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. The owner of the winner to receive a trophy. Nominations closed Saturday, September 11, 2010 with 25 nominees. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at 1 1/16 Miles).

MOGUMBO CAT tracked the pace along the inside and in hand, moved out a bit for the drive, set down, fully extended, late bid, just up. SPRIGHTLY STAR showed the way into the first turn, got clear before a half, got a bit of a breather in the second turn, still clear a furlong out, proved stubborn when challenged at the end. DEPUTIFORMER lacked speed, moved a bit closer between foes and in some traffic late in the final turn, came four wide into the straight, staged a mild rally to be along for the show while not a threat to the top two. CLAUDIA'S FORUM lacked early foot, saved ground while improving position in the second turn, closest to the top two a furlong out, outkicked for the show spot. FIRST TO BINGO last to leave, trailed, inside into the lane, managed little in the way of a response. MILE MARKER closest to the leader for five furlongs, faltered. SLIGO JOE in the second flight while outside, gave way in the drive. EL ZAPATERO was finished early.
