Footnotes

TIME OF THE NIGHT pushed in at the start, moved up inside, boxed in turn, closer still into lane, steadied when in tight past the furlong marker, recovered and finished full of run up the rail to be in time. AEROBIC DANCER duelled up front off the inside, between foes midstretch, came in slightly late, led, caught final strides. FOLLOWING A STEWARDS' INQUIRY REGARDING THE STRETCH RUN, THE RESULT WAS ALLOWED TO STAND. DUE DAY duelled up front along the inside, allowed the winner the rail inside the furlong grounds, did not have enough in the late going. NINER'S STAR off the pace, mild advance four wide into the stretch, was going evenly in the late going. TARGET GIRL broke to the inside, advanced with a middle move through the turn to contend turning for home three wide, put a head in front a furlong out, faltered. HANNAH GIRL in some traffic late in the turn, lacked a late kick. BLAZE VENTURE within striking distance, lacked a kick in the drive. ZAMIRACLE lacked early foot, passed tiring foes. HEART OF HALEY remained back in failing to menace. GOLDEN GATORBAIT was also always outrun. REBEL'S BAG forwardly placed in the early going, gave way in the turn. ROBBIELEE broke in the air, trailed throughout.
