SMITTY'S SUNSHINE away quickly, set a lively pace while clear, maintained a daylight advantage to the wire under steady handling. SMOKEY DIPLOMACY chased the winner in vain, held the place in the late going. VOLOBEE (FR) back early, crossed to the rail when advancing stretch, missed the place. EIGHTFORBISH went evenly paced throughout in lacking a winning kick. GO GIRLFRIEND GO was never dangerous. TOWN SCANDAL off slow, failed to menace. SCOTT'S DOLL tired after a half. SKIP AND SPLASH finished early. VICTORIA REGINA bobbled, steadied at the start, trailed.
