CARR DE DANCER unhurried early, began a steady advance after a half, came three wide into the stretch, drew out, driving. SHUDABEN FRANCA within striking distance, three wide into the stretch, second best. WAHTOWAH BABY back early, advanced and split foes exiting the final turn, finished best of the rest. FABULOUS MAID far back for six furlongs, swung to the far outside for the drive, displayed late interest middle of course. CUBAN COFFEE set the pace for over six furlongs and weakened when headed by the winner. JOYFUL WHIRL off slow, came three wide into the stretch, lacked the necessary rally. MISS CAT TAIL broke out, five wide first turn, advance and was also wide in the second turn, flattened out in the drive. ROAMING ANNIE saved ground into the stretch to no avail. BABY GENIUS failed to menace while racing off the inside. GARLAND COUNTY retreated while racing toward the inside. EMERALD FLAME closest to the leader for six furlongs, also backed up down the stretch. BLUFFTHEPASS far back, trailed home.
