### Footnotes

LAWYER RON close from the start, dueled backstretch while off the inside, shook well clear stretch to win ridden out. CASPER WHO void of early foot, began to advance after a half, moved out for the drive, up for the place late. DANSEUR'S GOLD lacked speed, advanced with a three wide middle move in the second turn, closest to the winner past the furlong marker, flattened out and was caught for the place at the wire. WARWICK WONDER settled early, moved a bit closer late in the final turn, lacked a further bid. STEEL PIER cleared early up front, dueled inside the winner the middle half mile, faltered in the drive. LISSA'S STAR had nothing left for the stretch run. HERMAN MUTTSTER faded. REGAL STAR never involved. SHERI'S RUBIANO in traffic early, gave way before a half, finished far back.
