Footnotes

CLUEMASTER veered in sharply to bump rivals at the break, rallied between rivals to move clear into the turn and maintained a steady advantage out from the rail. Following a claim of foul by the rider of BUSTER'S SHADOW, CLUEMASTER was disqualified and placed second for causing interference at the start. BUSTER'S SHADOW was bumped hard between rivals and squeezed back to last at the start, rallied four wide through the turn then could not run down the top horse late. CASE ON ICE was bumped hard at the start, followed the pace from along the inside to late in the turn, angled out entering the lane and lacked a final closing response. DAZZLIN JACK was bumped at the start, saved ground to late in the turn, angled out into the lane but lacked a final bid. RYAN'S WAY saved ground and failed to threaten. SMOKEON was always back racing four and five wide. DAT GUY showed brief speed from four wide and tired. BLUMIN STAR moved clear in the opening quarter racing out from the rail and steadily dropped back.
