TRANSEPT'S AFFAIR pressed the pace, raced three deep and held gamely in the lane to be clear under strong encouragement. BINGOSABLUMIN was allowed to settle early, moved up four wide at the eighth pole but couldn't match strides with the winner in the final stages. BENJAMIN E. was unhurried early, moved up five wide in the lane and made a good late run. GOATFEATHERS pressed the pace from the inside and tired. PRIME PRINCE was off slowly, vied for the early lead and tired the final quarter of a mile. TOOTS AND DAZZLES was off slowly and never menaced. SPOOKY THUNDER failed to sustain a bid.
