### Footnotes

ZENA'S AFFAIR showed good early speed, dug in at the eighth pole and prevailed under all out pressure. BEADED was shuffled back at the start, moved up three wide to challenge through the far turn and just missed in a game effort. ACUTE VELOCITY was squeezed back at the start, saved ground and had no late winning bid. CHELSEA'S KITTY stalked the pace while racing three wide and weakened. NO ICE PLEASE was slow early, raced five wide in the lane and passed tired ones. HIGH SPEED JUSTICE vied for the lead along the inside and tired. AFTANOOON TEA raced six wide into the upper stretch and never was a factor. SUNDAY DANCER failed to menace. GONE BERTIE failed to sustain a bid. NOTHINGFEARED was bumped at the start and tired.
