HOWARD COUNTY HANK was allowed to settle early, moved up four wide down the backstretch and drove clear in the final stages under strong pressure. COLOR OUT stalked the pace, raced three wide and was clearly second best. SHOW MY DANCER was allowed to settle early, raced four deep and had no final winning bid. COMEONLITTLEMAN was slow early, raced five wide into the upper stretch and improved his position. AGGIES RULE pressed the pace and gave way. MINNESOTA SLEW failed to respond. DECA failed to sustain a bid. MARCO DE ESPERANZA showed little. ZACK CAPE vied for the early lead and tired.
